- 6 **DEFINITIONS:** This is not a mandatory section but should be used with certain terms used
- 7 in the act that need to be defined or when it is desirable to substitute a single word for a
- 8 long phrase that will be used many times. Do not define words that are being used in their
- 9 normal dictionary meaning. List defined terms alphabetically. Enclose defined terms in
- 10 quotation marks.
- 11 **EXAMPLE:** SECTION 1. DEFINITIONS. As used in the Fish Act:
- 12 A. "department" means the department of game and fish;
- B. "fingerling" means a fish shorter than six inches in length;
- 14 C. "fish" includes both game fish and nongame fish, but does not include carp;
- D. "fund" means the fish replenishment loan fund:
- E. "hatchery" means a fish farm licensed by the department and the federal department of the interior; and
- F. "poaching" means the taking of fingerlings from a lake or stream in the state by someone other than a department representative.

- 21 MAIN PROVISION SECTIONS: This mandatory section lists the main provisions of the bill

- 24 **EXAMPLE:** SECTION 2. PERMITS. Permits shall be obtained from the pigeon protection

- 1 **PENALTY:** This is not a mandatory section but if choosing to enforce a penalty use the
- 2 following format "... shall be punished by a fine of not more than _____(\$) or by
- 3 imprisonment for a definite term not to exceed _____, or both."
- 4 **EXAMPLE:** SECTION 3. REMOVING BONES PERSONAL USE PENALTY. Any
- 5 person who removes bones from public property for personal use is guilty of a
- 6 misdemeanor and shall be punished by a fine of not more than five thousand dollars
- 7 (\$5,000) or by imprisonment for a definite term not to exceed one year, or both.

- 9 **APPRIOPRIATION:** This is not a mandatory section but if creating a bill that requires funds
- be appropriated for its use then it must be included. Required items include the amount of
- money, the source for the money, where the funds are going to, the time period the money
- can be used, the purpose for the funds and what will happen to any moneys remaining after
- the time period ends. If including this section in your bill you must include the phrase
- 14 "MAKING AN APPROPRIATION" into the full title of your bill.
- 15 **EXAMPLE 1:** SECTION 4. APPROPRIATION. Twenty-five thousand dollars (\$25,000) is
- appropriated from the general fund to the orchard inspection commission for expenditure in
- fiscal year 2019 to carry out the provisions of the Prune Act. Any unexpended or
- unencumbered balance remaining at the end of the fiscal year 2020 shall revert to the
- 19 general fund.
- 20 **EXAMPLE 2:** SECTION 4. APPROPRIATION. One hundred thousand dollars (\$100,000)
- 21 is appropriated from the general fund to the tree farm fund for expenditure in fiscal year
- 22 2020 and subsequent fiscal years to provide loans to tree farmers as provided in the Tree
- Farm Loan Act. Any unexpended or unencumbered balance remaining at the end of a fiscal
- year shall not revert to the general fund.

- All laws, acts, provisions, or parts of laws contained in the Constitution of the State of New
- 2 Mexico in conflict with any provision of this act are hereby repealed.

- 4 **EFFECTIVE DATE:** For this mandatory section select an option and copy word for word,

- 6 **EXAMPLE 1 Default Start:** This act shall become effective 90 days after its passage and
- 7 approval by the American Legion Auxiliary New Mexico Girls State Governor or it's
