8	RELATING TO A SCHOOL DISTRICT'S DECISION TO ALLOW CORPORAL
9	PUNISHMENT; DECIDING ON DISCIPLINARY ACTION WHEN RULES ARE BROKEN,
10	ACCORDING TO A CERTAIN DEGREE, PROVIDING LIMITATIONS.

15	SECTION 1. DEFINITIONS

- 1 A. Corporal Punishment physical punishment
- 2 B. Disciplinarian a person who practices firm discipline
- 3 SECTION 2. DISTRICT CHOICE It shall be the individual School District's choice on the
- 4 allowance of Corporal Punishment. The District in choosing to allow these forms of
- 5 punishment are required to submit a plan to the Board of Education, that outlines the steps
- 6 in which they will take to implement these procedures.
- A. The plan must indicate a list of rules they implement at schools, for what standard of
- 8 rule breaking they will be punished, and how they plan to take action.
- 9 SECTION 3. CHAIN OF COMMAND The individual schools are required to follow a
- system in which disciplinary actions are approved by a committee including principal,
- counselor, and dean of students.
- 12 SECTION 4. NATURE OF PUNISHMENT. The degree of punishment will be determined
- to which rule was broken and the extent the rule was broken, in a fair manner.
- 14 SECTION 5. DISCIPLINARIAN. For each school, there shall be two school employees,
- one male and one female, appointed to be the disciplinarian for separate sexes alike.
- A. The disciplinarian will be required to report every detail to the school and actions that
- 17 took place.
- B. The child to whom is receiving punishment is allowed to chose between both female
- and male disciplinarian on whom will be the disciplinarian.
- 20 C. The Disciplinarian must report the punishment received by the student to their legal
- 21 guardian under law.
- 22 SECTION 6. FAILED REPORTS. Failing to report incidents that take place the school and
- 23 staff will be flagged by the Board of Education. They will be given warnings and be
- supervised by trained personal.
